Note on data management/access and pre-analysis plan

Date: December 1, 2016

We expect that data collection for the SCY F2 Module, the most recent follow-up survey seeking to measure outcomes of over 2,000 individuals who were part of a set of vocational training and unconditional cash grant interventions, will end in early December 2016.

As of December 1, 2016, we have not filed our pre-analysis plan outlining the key research outcomes and estimating equations related to our study on the impacts of vocational training vouchers and cash grant provision, which will use this data. The pre-analysis plan is under preparation by Joan Hamory Hicks, Michael Kremer, Isaac Mbiti, and Edward Miguel, with assistance from Max Mueller, and will be uploaded to the AEA RCT Registry at a future point in time, hopefully in mid-December 2016.

The survey data will be compiled, organized, and stored by the field management team based in Busia, Kenya. This team, consisting of Eric Ochieng and Emma Smith, will not provide the individuals writing the pre-analysis plan with this data. This team will also not perform any analysis of this data using the treatment status measures, other than to check for differential attrition in tracking and surveying.

Full access to the dataset will be provided to all research team members once the pre-analysis plan has been filed on the AEA RCT Registry.
