Main Study, Victim Condition – No Punishment

Informed Consent

Please read the following information about this research study and click the "I accept" button at the bottom of your screen if you are interested in participating.

The following survey is a study on bystander preferences for restoring justice after a transgression. You have been selected to participate in this study because you are a user on Prolific, the platform we are employing to administer our study.

You must be 18 years or older to participate in this survey.

This web-based survey will take approximately 6 minutes to complete. You will receive \$1.50 for completing it in full (and you may earn a portion otherwise). By choosing to participate you will help expand the knowledge about third-party preferences regarding punishment.

Your decision to participate is strictly voluntary and involves only the risk of mild psychological discomfort sometimes associated with choosing whether to take bonus money from a fellow participant. You are free to answer all, some or none of the questions on the survey. You may withdraw from participating at any time and to do so you simply close your internet browser. Declining to participate will involve no penalty to you.

If you submit a survey, your responses are recorded without any personal identifiers, so your responses are completely anonymous. We hope to gather approximately 500 responses. Data will be stored on a secure server and can only be accessed by the research team.

Reasonable and appropriate safeguards have been used in the creation of the web-based survey to maximize the confidentiality and security of your responses; however, when using information technology, it is never possible to guarantee complete privacy.

As part of a previous study, two participants - who we'll call Alex and Brad - completed some transcription tasks for us, and were each given \$10 in bonus money.

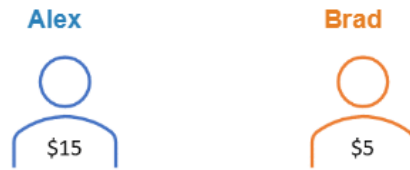


Then, Alex was given the chance to take \$5 from Brad. Click "Next" to see what they chose.

We vary the names across participants. All offenders begin with “A” and all victims begin with “B”. We have both male pairs and female pairs of names.

Alex chose to take \$5 from Brad. So, Alex's bonus payment **increased** to \$15 and Brad's **decreased** to \$5.



After Alex took \$5 from Brad, we informed Brad that another participant in a **future study** would be given an opportunity to reduce Alex's bonus payment.

*(To be clear, that future study is the one **you** are currently taking.)*

We further told Brad that any money taken away from Alex would go back to our Prolific account, not to Brad. So Brad's payment would stay at \$5, regardless of how much Alex's payment was reduced.

We then asked Brad, "*How much would you like the participant in the future study to reduce Alex's bonus payment by (if at all)?*" and gave them a set of options to choose from.

Click "Next" to see what Brad's response was.

Brad indicated that they **didn't want** the future participant to reduce Alex's payment at all.

Now, *you* will decide how much to **reduce Alex's payment by (if at all)**. You can pick any amount between \$0 and \$15. This money would go back to our Prolific account. (So again, regardless of your decision, Brad's payment would stay at \$5.)

We won't reveal your decision to Brad.

After the current study is over, we'll select one participant from it and **actually implement their decision** to determine Alex's payment.

For example, if you chose to decrease Alex's payment by \$3, and your decision was selected to be implemented, we'd decrease Alex's payment from \$15 to \$12. Brad won't learn about the decrease.

There's a chance we'll select your decision to determine Alex's bonus payment. So take your decision seriously!
